The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. A stamped copy of the draft labeling for the basic product, Ecozone Insect Powder, is enclosed for your records. Submit five copies of the finished printed label before the product is released for shipment.

- 1) Delete the claim, " but mild for application in the home".
- 2) Delete the claim, "yet mild enough for use in the home"
- 3) Delete the statements;

"One of the few active ingredients registered for use in food processing establishments. Unfortunately, it fell into disuse in homes when powerful petrochemical poisons became popular. Usually pyrethrin is combined with the synthetic synergist, piperonyl butoxide, which is suspected of interfering with the body's ability to handle toxic substances in general."

4) Delete the claim for use of the product on pet birds. The claim does not appear on the basic label and no directions are given for this use.

Our records now show that the basic label for the product bears the name, Ecozone Insect Powder. This label bears all the accepted uses for the product and should be the label used when amending the registration. The following additional brand names are

also accepted:

Natural Animal Herbal Flea Powder

Natural Animal Dog Flea Powder

Natural Animal Cat Flea Powder

ZAP Roach, Ant, Flea, Silverfish Powder

Herbal Animal Brand POW Herbal Flea POwder

The labeling for the additional brand names must comply with the labeling accepted as the basic label with the exception that fewer use may be claimed as long as all uses appear on the basic label. Labeling for additional brand names are not stamped.

Note that on the label for the additional brand name, ZAP roach, Ant, FLea, Silverfish, the registration number must be changed from EPA Reg. No. 45220-6 to EPA Reg. No. 45220-1.

DIRECTIONS FOR USE.

Control of Fleas and Ticks: Dust thoroughly all infested areas, particularly crevices in woodwork, floors, as well as mattresses, and other pet sleeping areas. 1 to 2 days after application, areas may be vacumed to assist in control of fleas. Repeat as needed.

Control of Bedbugs: Dismantle beds completely and dust all parts thoroughly, including mattress seams and box springs. Dust all baseboards and wall cracks thoroughly. Repeat if needed.
