For pools having just visible algae growth, add an initial dose of 11 to 17 fluid ounces of this product per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool, add initially 6 to 11 fluid ounces of this product per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of this product per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools or hot tubs having just visible growth require an initial dose of $\frac{1}{2}$ to 1 teaspoon of this product per 100 gallons of water.
