Adjust water pH to 7.2 - 7.6 as determined by a test kit. For pools with copper plumping best pH factor is 7.6 - 7.8. If the pool has not been previously stabilized, add conditioner and stabilizer (cyanuric acid). Follow directions for use on the label for that product.

Please Note: The pH of Aqua Tabs® is on the acid side and will tend to reduce the pH and alkalinity of the pool water. Proper pH should be maintained at pH 7.2 - 7.6 as determined by a test, by periodic additions of sodium carbonate or sodium bicarbonate. Superchlorinate swimming pool water at regular intervals to destroy accumulated organic wastes, algae, and bacteria. Use Aqua Shock™ or Aqua Burn® as directed for best results.
