Free 'N Clear Algaecide is effective against the growth of the following types of algae: *Pyricularia* (green algae), *Chlorella* (blue-green algae) and *Phormidium*.

For best results, pool should be treated before adding. The filter should be cleaned before adding the algaecide. At least six (6) hours after adding the algaecide, swimmers should not enter the pool. Add Free 'N Clear Algaecide by pouring around entire outside of pool.

Initial Application: (Original treatment - algae not visible): Add (1) quart of Free 'N Clear Algaecide per 12,500 gallons of pool water. Vacuum and treat with initial dose. Vacuum and remove algae debris. If visible algae or reappear, repeat this procedure. When pool is free of algae, resume maintenance dosage.

Maintenance Application: Maintain pool with 1 ounce of Free 'N Clear Algaecide per 12,500 gallons of water of ratio thereof, shake well and add at intervals. If high temperature or unusually heavy use, add more frequently. If make-up water is added more than 10% per week of pool water, add 1 ounce of Free 'N Clear Algaecide for each 10% of fresh make-up water added.
