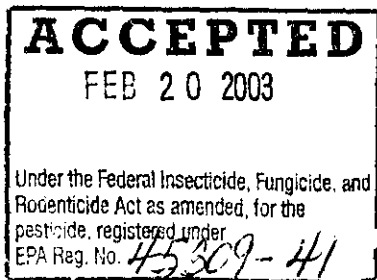

WINTERIZING TREATMENT

Swim Free Non-Foaming Winterizer is formulated to help keep pool water free from algae during the winter non-swimming season. This product is non-foaming and is non-corrosive to pool filters, heaters, piping and fittings when used as directed. The use of this product will not replace the need for chlorination to maintain proper sanitation.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions.

When the swimming season is over, clean out leaves and other debris. Balance pool water, including adjusting pH to proper range. Then, apply 42 fluid ounces of this product per 10,000 gallons of water. Add the correct dosage of this product by evenly distributing around the edge of the pool then circulate water for a minimum of two hours before proceeding to the next step. Next, winterize the pool and equipment per the manufacturer's directions. Cover the pool with a pool cover; check with the pool manufacturer as to size and type.

Length x Width x Average Depth (in feet) x 7.5

Round Pools:

Diameter x Diameter x Average Depth (in feet) x 5.9

STORAGE AND DISPOSAL Keep this product in original tightly closed container when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. **CONTAINER DISPOSAL:** Do not reuse container, but place in trash collection. Rinse thoroughly before discarding in trash.
