Confidential Statement of Formula (CSF)

The CSF declares a bulk density value of 9.5 lbs. per gallon, however your transmittal letter indicates the bulk density to be 8.53 lbs. per gallon. You must provide the correct declaration of bulk density on the CSF to reflect the data as reported in the transmittal letter.


In accordance with PR Notice 2001.1, the First Statement must contain the statement: "Have the product container or label with you when calling a poison control center or doctor".

NET CONTENTS:

This algaecide is especially made to control algae growth in all types of swimming pools. Its long lasting action controls existing algae and maintenance dosages will control algae regrowth. This algaecide will not cause the water to foam and will not alter the pH or chlorine residual of the water.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions.

INITIAL DOSE: Apply by pouring directly into the pool water, 7 fluid ounces of this product per 10,000 gallons of water or ratio thereof.

MAINTENANCE DOSE: 3½ fluid ounces of this product should be poured directly into the pool for every 10,000 gallons of water or ratio thereof.

NOTE: Wait at least 15 minutes after application before entering pool.

Initial dose is used when filling the pool at the beginning of the swimming season. If the pool has visible algae growth, treat with initial dosage. Vacuum after 24 hours to remove algae debris. If algae are still visible or reappear, repeat this treatment procedure as necessary. When pool is free of visible algae, use the recommended maintenance dose.

Maintenance dose should be added at two week intervals. If high temperatures prevail or the pool has unusually heavy use, add maintenance dose more frequently.

POOL FORMULA

Rectangular or Square Pools:

Length x Width x Average Depth (in feet) x 7.5

Round Pools:

Diameter x Diameter x Average Depth (in feet) x 5.9

STORAGE AND DISPOSAL Keep this product in original tightly closed container when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. **CONTAINER DISPOSAL:** Do not reuse container, but place in trash collection. Rinse thoroughly before discarding in trash.
