KEEP OUT OF REACH OF CHILDREN

Corrosive. Causes eye and skin damage. Harmful or fatal if swallowed. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and gloves when handling.

### STATEMENT OF PRACTICAL TREATMENT (FIRST AID)

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before re-use.

If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution; or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, as well as oxygen and measures to support breathing manually or mechanically may be needed.

### ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Treated effluent should not be discharged where it will drain into lakes, streams, ponds or public waters.

### STORAGE AND DISPOSAL

- Do not contaminate water, food or feed by storage or disposal.
- Open dumping is prohibited.
- Do not reuse empty container.

### PESTICIDE DISPOSAL

Pesticide or rinsate that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides, or buried in a safe place, away from water supplies.

### CONTAINER DISPOSAL

Triple rinse (or equivalent) and dispose in an incinerator or landfill approved for pesticide container, or bury in a safe place.

### GENERAL

Consult federal, state or local authorities for approved alternative procedures such as limited open burning.

## Winter Algicide-5:

- is the efficient and economical way to improve the appearance and cleanliness of your pool.
- requires no special equipment for treating water.
- may be added directly to the pool or to the water circulating equipment.
- may be stored for prolonged periods of time without losing its effectiveness or strength.

### DIRECTIONS FOR USE:

Use only as directed

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Winter Algicide-5 is effective in controlling the growth of the following types of algae: Chloroella pyrocladosa (green algae), Phormidium truncatum (blue-green algae) and Phormidium ritzii.

For best results, pool water should be free of algae before adding Winter Algicide-5. The filter should be circulating the pool water when adding algicide. Allow the filter to run for at least six (6) hours after adding algicide. . . . during this period, swimmers should not be allowed in the pool. Add Winter Algicide-5 directly to the pool by pouring around entire inside perimeter of pool.

**Winter Application:** Add Winter Algicide-5 at the rate of one (1) quart per 10,000 gallons of pool water by pouring directly into pool, around entire inside perimeter of pool. This will help control algae growth over the winter and make for easier clean up in the spring.

**Initial Application:** (Original filling or when algae are not visible). Add one (1) gallon of Winter Algicide-5 per 25,000 gallons of pool water (2 ppm active ingredient). If algae are visible, use four (4) gallons of algicide per 25,000 gallons of pool water (8 ppm active ingredient) followed by cleaning out of dead, settled algae. Then add one (1) gallon of algicide immediately (2 ppm active ingredient) to prevent further algae growth.

**Continuing Application:** Add one (1) quart of Winter Algicide-5 per 25,000 gallons of pool water every three (3) to five (5) days.

**Booster Application:** Add one (1) gallon of Winter Algicide-5 per 25,000 gallons of water when bathing load is heavy or after heavy or prolonged rainfall.
