Dear Mr. Jernigan:

The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with the condition listed below:

- To amend basic and alternative formulations (see CSFs dated 6/5/03)
- To update the "first aid" statement in accordance with PR Notice 2001-1

Condition

- Under the "Storage and Disposal" on the label add sub-heading "Storage" under that add "Keep product dry in tightly closed container when not in use. Store in a cool, dry, well ventilated area away from heat or open flame". Add another sub-heading "Disposal" under that add "Do not reuse empty container. Rinse empty container thoroughly with water to dissolve all material before discarding. Securely wrap container in several layers of newspaper and discard in trash". This is required under PR 84-1. For containers larger than five pounds follow PR Notice 83-3.

General Comments

The revised basic confidential statement of formula (CSF) dated 6/5/03 supersedes all previously accepted basic formulas.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions.

This product is designed to dissolve quickly and completely providing a steady source of available chlorine in swimming pools to control the growth of algae, kill bacteria and destroy organic contaminants.

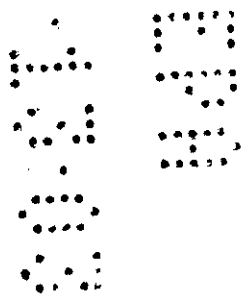
READ THE PRECAUTIONARY STATEMENTS BEFORE USE

1. Adjust water pH to 7.2 to 7.6 as determined by a test kit. For pools with copper plumbing, best pH factor is 7.6 to 7.8.
2. If the pool has not been previously stabilized, add Chlorine Stabilizer (cyanuric acid). Follow the directions for use on the label for that product.
3. Secure the chlorinator in the area of the pool that is agitated by the return flow from filter. If residual remains too high, chlorinator should be moved further from the agitated area which will slow the dissolving action of the tablets.
4. In newly filled pools, follow steps 1 through 3, then add two (2) tablets per 5,000 gallons of pool water to establish a chlorine residual of 1.0 to 1.5 ppm as determined by a test kit. Repeat dosages as needed to maintain a chlorine residual of 1.0 to 1.5 at all times. Thereafter, add one (1) tablet per 5,000 gallons per week or as needed to maintain a chlorine residual of 1.0 to 1.5 at all times as determined by a test kit.

Reentry into swimming pool is prohibited above levels of 3ppm chlorine.

SUPERCHLORINATION: Superchlorination is necessary at the start of the bathing season, upon filling the pool, every week during the hot weather and following heavy rains. Superchlorination is performed by adding two to three times the normal amount of chlorine to oxidize and remove unwanted organic and inorganic material. A granular chlorinated agent, which will dissolve quickly, should be used for superchlorination. Follow the directions for use found on the granular product labeled for superchlorination use. Bathers should not be permitted to enter the pool during superchlorination until the chlorine residual is less than 3.0 ppm.

Please note: The pH of this product is on the acid side and will tend to reduce the pH and total alkalinity of the pool water. Proper pH should be maintained at pH 7.2 - 7.6 as determined by a test, by periodic additions of sodium carbonate or sodium bicarbonate.



STORAGE AND DISPOSAL: Keep product dry in tightly closed container when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. Do not reuse empty container. Rinse empty container thoroughly with water to dissolve all material before discarding. Securely wrap container in several layers of newspaper and discard in trash.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS:

DANGER. CORROSIVE: Causes irreversible eye damage and skin burns. May be fatal if absorbed through the skin. May be fatal if inhaled. Do not breathe dust or spray mists.
