The following amendments, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, are acceptable:


- Increase the re-entry level to 4ppm chlorine

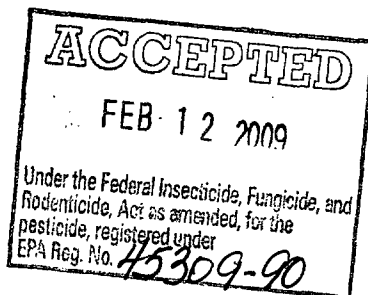

SWIMMING POOL SANITIZER

This product is for use in white plaster pools only. When used as directed this product is effective as a pool water sanitizer. Do not use this product in painted, vinyl-lined, fiberglass or colored plaster surface pools.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions.

Ensure all pool equipment is working properly. Clean or backwash filter following manufacturer's directions. Adjust pH to between 7.2-7.6. Add stabilizer to establish a minimum stabilizer level of 30-40 ppm to reduce the degradative effects of sunlight upon the chlorine residual. When using other products as outlined in directions for this product, always follow directions on those products.

With pump running, broadcast 4 ounces of this product per 10,000 gallons directly into the water in the deep end of the pool as an initial treatment. Repeat additions until a residual of 1-4 ppm of available chlorine is established as determined by the use of a test kit or test strips.

Regular use of a test kit or test strips is necessary to determine when it is necessary to add another dose of this product to maintain a residual of 1-4 ppm available chlorine in the pool water. An average daily dose requirement is 2-3 oz. of this product per 10,000 gallons of water.

Reentry into treated swimming pools is prohibited above levels of 4 ppm chlorine due to risk of body injury.

SWIMMING POOL ALGAECIDE

When used as directed, this product kills algae and will rid your pool of unsightly algae spots. Use this product only in WHITE PLASTER POOLS. DO NOT USE this product in painted, vinyl lined, fiberglass or colored plaster surface pools as damage may occur to the pool surface.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions.

Ensure all pool equipment is working properly. Clean or backwash filter following manufacturer's directions. Adjust pH to between 7.2-7.6. Add stabilizer to establish a minimum stabilizer level of 30-40 ppm to reduce the degradative effects of sunlight upon the chlorine residual. When using other products as outlined in the directions for this product, always follow directions on those products.

Before using this product, shut off pump and brush all surface clinging algae. Wait four hours for the water to become stationary before product application. At night or when the pool is not in use, broadcast this product directly into the water in areas of heaviest algae growth. Use two pounds of this product per 10,000 gallons for medium to heavy algae growth and one pound per 10,000 gallons for light algae growth. Twelve to twenty-four hours after applying this product, turn pump on and vacuum dead algae through the filter. Brush any remaining algae and clean/backwash filter. If algae is still visible, repeat treatment.

[TO DETERMINE POOL CAPACITY: Rectangular Pools - Length times width time average depth (in feet) times 7.5 equals gallons. Round and Oval Pools - Long diameter times short diameter times average depth (in feet) times 5.9 equals gallons.]
