DIRECTIONS FOR GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Alstar Liquid Spa Algaecide is used in swimming pools, exterior spas, whirlpools, hot tubs, and indoor swimming effectiveness pools, spas, whirlpools, hot tubs, and hot tubs. Heavy growth of algae should be cleaned prior to using.

For pools having just visible algae growth add an initial dose of 41 fluid ounces of Alstar Liquid Spa Algaecide per 10,000 gallons of water. Subsequent additions of Alstar Liquid Spa Algaecide should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a freshly installed hot tub, or decorative fountain, add initially 4 fluid ounces of Alstar Liquid Spa Algaecide per 1,000 gallons of water.

Alstar Liquid Spa Algaecide should be made every 5 to 7 days after initial treatment.

Alstar Liquid Spa Algaecide is compatible with chlorine chemicals normally required. However, do not mix Alstar Liquid Spa Algaecide with concentrated dry or liquid chlorine products.

INERT INGREDIENT 90.0 %

This product contains 0.85 lb. of active ingredient per gallon and weighs 8.49 lb. per gallon.
