Label amendment in response to propoxur RED and efficacy DCI

Chem-Tox Roach and Ant Spray with Baygon

EPA Registration No. 45385-1

Submission Date: September 11, 2008

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following changes before you release the product for shipment bearing the amended labeling:

- Change all references to "roaches" and "resistant roaches" so they read "German roaches."
- Change all references to "ants" so they read, "ants (excluding fire, harvester, carpenter, and pharaoh ants)." These types of ants require additional data.
- Change all references to "spiders" so they read, "spiders (excluding brown recluse spiders)."
- Add the following statements to the front panel:
  - o For use in commercial and industrial buildings, including the non-food areas of food-handling establishments (non-food areas are garbage rooms, entries and vestibules, lavatories, floor drains, offices, locker rooms, boiler rooms, machine rooms, garages, mop closets, storage after canning/bottling, warehouses where food is not exposed, ships, trains, trucks).
  - o "Do not spray product on indoor residential use sites, schools, day care facilities, motels, hotels, and other indoor locations where children may be present."
- Revise the sentence directly above the ingredients statement so it reads, "See side panels for **First Aid** and additional Precautionary Statements."

- Revise and place the following text as a separate section after the Hazards to Humans and Domestic Animals section:

#### Personal Protective Equipment (PPE):

Applicators and all handlers must wear:

- Long-sleeved shirt and long pants,
- Socks and shoes, and
- Chemical resistant gloves made of barrier laminate, nitrile rubber, neoprene rubber, or viton.

Follow manufacturer's requirements for cleaning/maintaining PPE. If there are no such instructions for washables, use detergent and hot water. Keep and wash PPE separately from other laundry.

- Revise and place the following text as a separate section after the PPE sections:

#### **User Safety Recommendations**

- Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet.
- Users should remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing.
- Users should remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.
- Move the last four sentences under the Hazards to Humans and Domestic Animals section and place them under the Directions for Use.
- Under the Note to Physician, revise the first two sentences as follows: "Contains petroleum distillate may pose an aspiration pneumonia hazard. Contains an N-methyl carbamate that inhibits cholinesterase."
- Under the Directions for Use, delete the following statement: "This spray is a highly effective formulation that provides..." or revise as follows: "This spray provides rapid kill of listed crawling insects."
- Under the Directions for Use, delete the following statement: "In addition to rapid kill, ROACH AND ANT SPRAY with BAYGON stays on treated surfaces and kills insects many weeks after the spray deposit has dried." The data submitted do not support residual or control claims.
- Add the following statements under the Directions for Use: "Will only kill pests present at the time of application. Pests must be directly contacted to be effective. Contact as many pests as possible."
- Delete all references to "wasps," "hornets," "mosquitoes," and "scorpions."

- Under the Indoor Use paragraph, delete the reference to "house plants," as house plants implies residential use.
- Under the Brown Dog Ticks paragraph, add the following text as the first sentence: "For use in kennels." Also, change the word "pets" to "animals."
- Under the Precautions section, replace the word "should" with "must" so the statements are mandatory rather than advisory. Replace "Take care not to" with "Do not."
- Under the Conditions of Sale, insert the following text before the last sentence so it reads, "To the extent consistent with applicable law, the Seller offers, and the Buyer accepts..."

Approval of this labeling amendment does not constitute approval of your application for reregistration of this product. Product reregistration is currently pending and future labeling amendments and/or additional data may be required.

A stamped copy is enclosed for your records. Please submit two (2) copies of your final printed labeling before releasing the product for shipment. The following provisions apply to existing stocks:

- If you formulate your end-use product with technical product purchased prior to January 31, 2009 that IS NOT labeled with the prohibition on indoor residential spray use, then you may label your product with existing stocks for up to 12 months after the date of this amendment letter.
- If you formulate your end-use product with technical product purchased prior to January 31, 2009 that IS labeled with the prohibition on indoor residential spray use, then you may not use existing stocks of labels that allow for indoor residential use. You must use the new, stamped label that is enclosed with this amendment letter.
- If you formulate your end-use product with technical product purchased after January 31, 2009, then you may not use existing stocks of labels that allow for indoor residential use. You must use the new, stamped label that is enclosed with this amendment letter.

#### PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: May be harmful if swallowed, inhaled or absorbed through skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes or clothing should also be avoided. Wear long-sleeved shirt and long pants, chemical-resistant gloves, and shoes plus socks when making application. Wash thoroughly after using. Avoid contamination of food, utensils and food preparation areas. Do not contaminate food or feed. Keep out of reach of children. Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet. Users should remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Users should remove protective clothing and equipment immediately after handling this product. Wash outside of gloves before removing. Keep and wash protective clothing and equipment separately from other laundry. Remove pets and cover fish aquariums before spraying. Do not apply this product in a way that will contact any person or pet, either directly of indirectly. Keep people and pets out of the area during application. Do not allow people or pets to contact treated surfaces until they are dry.

#### FIRST AID



This spray is a highly effective formulation that provides rapid kill of such crawling insects as listed below, including those resistant to certain chlorinated hydrocarbon and phosphate insecticides: ANTS, FLEAS, BROWN DOG TICKS, FLIES, CLOVER MITES, HORNETS, CRICKETS, MILLIPEDES, SOWBUGS, EARWIGS, MOSQUITOES, SPIDERS, ROACHES, WATERBUGS, WASPS, SAWTOOTHED GRAIN BEETLES (exposed), SCOR-

In addition to rapid kill, ROACH AND ANT SPRAY with BAYGON® stays on treated surfaces and kills insects many weeks after the spray deposit has dried.

**HOW TO USE:** This product is ready to use undiluted as it comes from the container, and may be applied with either power operated or hand pressurized sprayers.

Apply as a course spray to surfaces until moist, moving the spray stream rapidly enough to prevent excess wetting of surfaces and waste of material.

INDOOR USE: Spray into cracks, crevices, around baseboards and other places where these insects hide, Apply behind and beneath cabinets, refrigerators, sinks, stoves and in and around waste containers. BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors, Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. DO NOT spray animals.

#### **OUTDOOR USE**

Spray thoroughly those areas where pests have been seen or found including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter the indoors. For ants, spray ant trails and mounds. For control of wasps, and hornets, apply after dark when all of the insects have returned to the nest. Repeat as necessary, Do not spray vegetation.

#### PRECAUTIONS:

- (1) Do not use this product indoors as an overall surface spray or as a space spray. Take care not to introduce this product into the air during application.
- Use only in well ventilated areas.
