### STATEMENT OF PRACTICAL TREATMENT

### DIRECTION FOR USE continued

Mosquitoes, Flies, Gnats, Flying Moth (Millers): Close all doors and windows. Direct the spray to all parts of the room. Fill the room with mist, then leave the treated area. Keep room closed for at least 15-20 minutes. Ventilate the room when treatment is completed.

Wasps: Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible. Repeat as necessary.

Roaches, Waterbugs, Earwigs, Grain Mites, Sowbugs, Spiders and Centipedes: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and

sinks, under refrigerators, baseboards and storage areas. Spray directly on insects when possible. Repeat treatment as necessary.

When using this product in food processing plants, foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using this product in these areas, apply only when the facility is not in operation.

Remove pets, birds and cover fish aquariums before spraying.

Do not remain in treated area and vacate the area after treatment is completed.
