### PRECAUTIONARY STATEMENTS

#### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### CAUTION

Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing vapors or spray mist. And provide adequate ventilation of area being treated. Contact with the eyes, skin or clothing should be avoided. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.

Do not allow children or pets to contact treated surfaces until spray has dried.

In home, all food processing surfaces, dishes and utensils should be covered during treatment or thoroughly washed before use. Do not apply directly to food.

In commercial food handling facilities, cover or remove any food and food processing equipment during application. Do not apply while food processing is underway. After spraying in food processing plants, wash all equipment, benches, shelving, etc. where exposed food will be handled with potable water.

#### ENVIRONMENTAL HAZARDS

This product is toxic to fish and wild life. Keep out of streams, rivers, ponds, and other bodies of water. Clean up spilled product with plenty of water. Do not discharge into water.

#### PHYSICAL HAZARDS

Do not use in storage near heat or open flame.

**SPACE SPRAY:** For rapid control of flies, fruit flies, mosquitoes, gnats, small flying moths, sand flies, wasps and hornets. Close doors and windows and shut off ventilation systems. Apply using a good machine adjusted to deliver a fine mist. Direct spray toward the upper portion of the room to fill the entire area with mist using 1 to 2 ounces per 1000 cubic feet of space. Vacate the treated area and ventilate before reoccupying. Keep the area closed for ten minutes after treating. Repeat application if reinfestation occurs.

**SURFACE APPLICATION:** To control cockroaches, silver fish, crickets and spiders. Apply as a coarse wetting spray directed into locations where these insects may hide behind baseboards, moldings, cabinets, shelves, sinks, door and window frames, around plumbing, drains and in dark corners and into cracks and crevices, hitting insects with the spray whenever possible. Repeat treatment as necessary.

Against ant infestations, treat shelves, cabinets and storage areas, spray ant runs, trails, baseboards, thresholds and other parts of entry and treat nests liberally. Repeat treatment as necessary.

In controlling fleas and brown dog ticks in houses, direct the application toward the lower wall portions, baseboards, rugs, carpets and floors of infested areas. Animal quarters, kennels and bedding should also be sprayed.

To control bedbugs, apply liberally to top ends, sides and bottom of mattresses, spraying thoroughly all tufts, seams and folds. Spray springs and frame, directing the liquid into all cracks and lock joints. Treat bed room walls, baseboards, linens, chairs, closets, furniture and picture frames, with particular attention to protected hiding and breeding places.

For most effective control of clothes moths and carpet beetles, remove infested articles from storage, brush thoroughly and if possible, air several hours in direct sunlight. Apply liberally in linen closets, closets, bureaus and storage sites, filling the liquid into cracks, joints and crevices. After airing, infested articles may be treated by holding the spray nozzle at least 3 feet away from the fabric and applying the liquid directly to the seams to avoid the possibility of staining. Treat both sides of rugs, carpets and pads and all exposed accessible surfaces of upholstered furniture. Do not oversaturate. Do not use on materials of rubber or are rubber treated. Do not use on silk, fur, or animal products. Repeat treatment monthly until all infested articles are stored in moth tight containers.

To control infestations of granary weevils, rice weevils, saw-toothed grain beetles, confused flour beetles, rusty grain beetles, red flour beetles, cadellies, meal worms, grain mites, angoumois grain moth, Indian meal moth, and Mediterranean flour moth in food storage areas. If possible, clean out and destroy any infested food products, otherwise fumigation or other effective treatment should be made using an approved product intended for this purpose. Apply this spray thoroughly to all surfaces of shelves, cabinets, bins, pantries, and similar food storage areas with particular attention to cracks, crevices, niches and other hiding places.

**FOGGING SPRAY:** To kill accessible or exposed stages of insects named on this label (excepting clothes moths, bedbugs, and carpet beetles). Apply using conventional mechanical thermal or compressed air equipment. Fill the entire area with mist using 3 to 6 ounces per 1000 cubic feet of space. Repeat treatment as needed.
