The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

- 1. For products 45385-9, 45385-3, and 45385-6, combine the "Related compounds" percentage with the total for inert ingredients. "Related compounds" should not be listed separately as an active ingredient.
- 2. For products 45385-3, 45385-6, and 45385-90, add the following statement to the "PHYSICAL AND CHEMICAL HAZARDS" ction:

"Do not use this product in or on electrical equipment due to the possibility of shock hazard."

3. For product 45385-3, add the following statement to the Haz: is to Humans and Domestic Animals paragraph:

"In food handling establishments, do not apply while food processing is underway."

- 4. For product 45385-3, note the correct spelling of "kill" under the directions for horse barns.
- 5. For product 45385-90, combine the "Other isomers" percentage in the ingredients statement with the total for inext ingredients. Do not list "Other Isomers" separately as an active ingredient.
- 6. For product 45385-90, check redundant wording in the "ENVIRONMENTAL HAZARDS" statement and correct the spelling of "food processing plants" on the front panel.


SPACE SPRAY: For rapid control of FLIES, FRUIT FLIES, MOSQUITOES, GNATS, SMALL FLYING MOTHS, SAND FLIES, WASPS and HORNETS: Close doors and windows and shut off ventilation systems. Apply using a good machine adjusted to deliver a fine mist. Direct spray toward the upper portion of the room to fill the entire area with mist, using 1 to 2 oz. per 1000 cubic feet of space. Vacate the treated area and ventilate before reoccupying. Keep the area closed for ten minutes after treating. Repeat application if reinfestation occures.

SURFACE APPLICATION: To control COCKROACHES, SILVER FISH, CRICKETS, and SPIDERS: Apply as a coarse wetting spray directly into locations where these insects may hide, behind baseboards, moldings, cabinets, shelves, sicks, door and window frames, around plumbing, drains and in dark corners and into cracks and crevices, hitting insects with the spray whenever possible. Repeat treatment as necessary.

Against ANT infestations: treat shelves, cabinets and storage areas; spray ant runs: trails: baseboards: thresholds and other places of entry; and treat nests liberally. Repeat treatment as necessary.

In controlling FLEAS and BROWN DOG TICKS in houses, direct the application toward the lower wall portions, baseboards, rugs, carpets and floors of infested areas. Animals quarters, kennels and bedding should also be sprayed. DO NOT TREAT ANIMAL WITH THIS PRODUCT.

To control BEDBUGS, apply liberally to top ends, sides and bottom of mattresses, spraying thoroughly all tufts, seams and folds. Spray springs and frame, directing the liquid into all cracks and lock joints. Treat bedroom walls, baseboards, moldings, floors, closets, furniture and picture frames, with particular attention to protected hiding and breeding places.
