1. Within the If swallowed statement, in the First Aid Section, replace "Have a person sip a glass of water if able to swallow" with "Do not give any liquid to the person."
2. Please note that the following statement is recommended to appear below the First Aid Section: "Have the product container or label with you when calling a poison control center or doctor, or going for treatment."
3. Replace "thandlers" with "handlers".
4. Relocate the statement "Do not contaminate water, foodstuffs, feed or seed by storage or disposal" so that it appears directly beneath the storage and disposal heading.
5. Relocate the warranty statement so that it appears either before or after the Directions for Use.
6. Change the "Precautions" heading to read "Precautions and Restrictions".
