

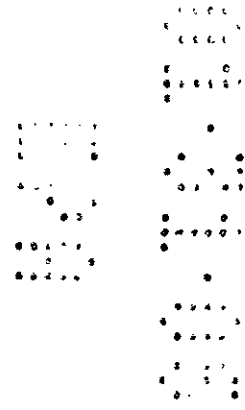

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in manner inconsistent with its labeling. Do not apply directly to food. In commercial food handling facilities, cover or remove any food and food processing equipment during application. Do not apply while food processing is underway. After Space Spraying in meat packaging plants, bakeries and other food processing plants, wash all equipment, benches, shelving, etc. where exposed food will be handled, with potable water. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Remove pets, birds, and cover fish aquariums before spraying. For maximum effectiveness, a combination of spot surface treatment and fogging is recommended.

SURFACE SPRAYING:

To control exposed or accessible stages of roaches, ants, silverfish, spiders, crickets, clover mites, cheese mites, granary weevils, rice weevils, confused flour beetles, rust red flour beetles, sawtoothed grain beetles, spider beetles, cigarette beetles, Drugstore beetles, meal worms, grain mites, and cadelles: Use a good sprayer adjusted to deliver a coarse wet spray, Direct the spray into hiding places, cracks and crevices, under pallets, around containers of stored foods, around the base of machinery, behind shelves and drawers. For silverfish, spray bookcases.

For ants, spray trails, nests and points of entry, If surface application only is to be used, spray floors, walls, and other surfaces applying at a rate of 1 gallon to 750 square feet of surface.

To control carpet beetles: Spray edges of carpeting and under carpeting and rugs. Make localized application to floor and baseboards. Spray directly into cracks, closets, and infested areas of shelving. Repeat treatment as needed.

To control bedbugs: Spray mattresses lightly, particularly around tufts and seams. Take beds apart and spray in all joints. Treat baseboards, mouldings, and floors. Repeat treatment as needed.

To control fleas and brown dog ticks: Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, mouldings, window and door frames, and all areas of floor and floor covering. Fresh bedding should be placed in animal quarters following treatment. Concurrent treatment of animals with an approved insecticide is recommended. Repeat treatment as needed.

SPACE SPRAYING:

Close doors and windows and shut off ventilating systems. Apply with a good machine adjusted to deliver a fine mist or fog. For rapid control of flies, fruit flies, gnats, mosquitoes, skipper flies, wasps, hornets, Angoumois grain moths, Mediterranean flour moths, Indian meal moths, and tobacco moths direct spray at an upward angle, distributing it uniformly throughout the entire area, at a rate of one gallon to 200,000 cubic feet of space..... continued.....

SPACE SPRAYING continued

To kill exposed or accessible stages of the above named flying insects, use a rate of one gallon to 80,000 cubic feet of space, Contact insects directly whenever possible.

BARNs, MILK ROOMs, DAIRY PLANTs: To control flies, mosquitoes, and gnats, apply as a fog or fine mist, directing spray toward the ceiling and upper corners, until the area is filled with mist, using about 2 ounces per 1000 cubic feet of space, For best results, close windows and doors before spraying and keep closed for ten to fifteen minutes, Vacate the area and ventilate before reoccupying. Repeat application as necessary.

FOR USE ON ANIMALs:

To protect horses, cattle and hogs from Horn Flies, House Flies, Mosquitoes, and Gnats apply a light mist sufficient to wet the tips of the hair of the animal. To control Stable Flies, Horse Flies, Deer Flies, apply 1 to 2 ounces per adult animal, sufficient to wet the hair but not to soak the hide. Repeat treatment once or twice daily or at intervals necessary to give continued protection.



OUTDOOR MOSQUITO, BITING FLIES and GNATS CONTROL:

To control adult Mosquitoes, Biting Flies and Biting Gnats apply as a fog or fine mist using suitable mechanical, thermal or compressed air equipment capable of producing aerosol spray droplets ranging in size from 5 to 30 microns: and a mass medium diameter (MMD) of 10 to 20 microns. Apply undiluted at a rate of 1-1/4 gallons per acre (or 3.6 fluid ounces per 1000 square feet). For best results, treat a 300 foot wide swath, down wind when wind velocity does not exceed 5 miles per hour. Application in the evening or early morning is recommended. Evacuate and do not remain in treated areas. Do not allow re-entry until fog has dissipated. For mosquitoes treat areas thoroughly with particular attention to low and marshy places, shore lines, stagnant pools or ponds, and shrubbery or vegetation where adult mosquitoes may rest. Do not directly treat any fish bearing waters.
