The amendment to remove the two synergists from this product referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable. The confidential statement of formula for the basic formulation (dated September 6, 1994) is acceptable and supersedes all previously accepted confidential statements of formula for this product.

The labeling submitted in conjunction with this request for amended registration is acceptable, provided you make the following changes:

- 1. Move the following paragraph from the Precautionary Statements to the Directions for Use:
 - "Do not contaminate feed, water or mineral supplements with this compound. Do not contaminate milk or milk handling establishments. Wash udder and teats before milking. Do not use in commercial food processing, preparation, serving or storage areas."
- 2. Revise the Statement of Practical Treatment to read as follows:

IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting. Do not give anything by mouth to an unconscious person. Avoid alcohol. Vomiting may cause aspiration pneumonia.

IF INHALED: Remove victim to fresh air. If not breathing,

give artificial respiration, preferably mouth-

to-mouth. Get medical attention.

IF ON SKIN: Remove contaminated clothing and

thoroughly with soap and water. attention if irritation persists. Get medical

IF IN EYES: Flush eyes with plenty of water. Get medical

attention if irritation persists.

Revise the Storage and Disposal Statement to read as follows: 3.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Avoid storage conditions that might alter

the composition of usefulness of the pesticide, e.g., temperature extremes, excessive moisture, or humidity, heat, sunlight. friction, or contaminating substances or media. Keep pesticide container closed in a cool, dry, locked

approved waste disposal facility.
