STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Do not induce vomiting. Vomiting may cause aspiration pneumonia. Call a physician or Poison Control Center immediately. ENVIRONMENTAL HAZARDS

This formulation is toxic to fish. Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes). Drift and runoff from treated sites may be hazardous to fish in adjacent waters. Do not contaminate water when disposing of equipment washwaters.

PHYSICAL AND CHEMICAL HAZARDS

Extinguish open flame before space spraying. This formulation is combustible. Do not use or store near heat or open flame.

DIRECTIONS FOR USE

IT IS A VIOLATION OF THE FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. STORAGE: Store product in original container in a locked storage area. PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. CONTAINER DISPOSAL: 1 Gal and under: wrap container in several layers of news paper and discard in trash. Over 1 Gal: Triple rinse (or equivalent) and offer for recycling, reconditioning or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

FLYING INSECTS: Cenol Mill Spray for control of flying insects. Foods should be removed or covert during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. After space spraying in food processing plants, wash all equipment, benches, shelving etc. where exposed food will be handled thoroughly with an effective cleaning compound rinse with potable water. When using this product as a space spray, apply only when plant is not in operation. Before spraying, close all doors and windows in area to be treated to prevent drift of spray. Extinguish all open flames and shut off all non-explosive proof electrical equipment. Spray into entire room directing spray upward at the walls and ceiling so that as many insects as possible can be contacted with the vapor or mist. Use a fogger or vaporizer adjusted to deliver an aerosol spray (no droplets over 50 microns in diameter and 80% less than 30 microns). Apply at a rate of 3 ounces per 1,000 cubic feet of space.

Treated area should be kept closed at least ten minutes after spraying. Repeat as often as necessary to keep named insects under control and deter new infestations. After thoroughly spraying as directed, sweep up all dead insects and destroy them.

CRAWLING INSECTS: Cenol Mill Spray for control of named crawling insects. Thoroughly clean, preferably by vacuuming, all flour, grain, and food dust from horizontal surfaces, since these static accumulations encourage stored product pest breeding. Spray with permanent unit's, portable electric sprayers, or air guns, into cracks, crevices, or any surface where the above named insects frequent. Apply into cracks of flooring and baseboards, also cracks inside and outside of flour, grain or food handling equipment or bins. thoroughly mist outside of storage sacks before storing. Spray box cars and storage rooms before filling with grain, feed, or food products. Repeat at regular intervals, or as often as necessary to control named insects.
