PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist, and provide adequate ventilation of area being treated. Contact with the eyes, skin or clothing should be avoided. Do not allow children or pets to contact treated surfaces until spray has dried. Remove birds, and cover fish aquariums before spraying. Do not use in serving areas while food is exposed. Remove food before treatment.

In homes, commercial, industrial establishments cover all food handling surfaces and cover and remove all food and cooking utensils. Food contact surfaces, dishes, and utensils must be washed with an effective cleaning compound followed by a potable water rinse after using this product.

Do not use this product on edible crops.

STATEMENT OF PRACTICAL TREATMENT

If swallowed: Induce vomiting by sticking finger in back of throat or by administration of syrup of Ipecac. Get medical attention. If in eyes: Flush with water for 15 minutes. Get medical attention if irritation develops or persists. If on skin: Wash with plenty of soap and water. Get medical attention if irritation develops.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not apply directly to water or wetlands (swamps, bogs, marshes, and potholes). Dust from treated areas may be hazardous to organisms in adjacent aquatic sites. Do not contaminate water when disposing of equipment wash waters. STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Do not store this water-base formulation below 32°F. For Containers 1 Gallon and Under: Store in original container in a locked storage area. **PESTICIDE DISPOSAL:** For Containers over 1 Gallon: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **CONTAINER DISPOSAL:** For Container 1 Gallon and Under: Do not reuse empty container. Wrap container and put in trash. For Containers Over 1 Gallon: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and Local authorities.

APPLICATION:

Instructions for CONTACT and RESIDUAL SPRAYS for INDOOR use:

For use in non-food areas of commercial, industrial, office residential, public, institutional and storage establishments and buildings, homes, hotels, shipcabins and hospitals. In hospitals patients should be removed prior to treatment. Room should be ventilated for two hours after spraying. Do not return patients to room until after ventilation. Also for use in buses, automobiles, and non-food areas of trucks, boxcars and ship cargo holds. Do not use on electrical or on surfaces that can be harmed or stained by water. Also for use indoors in dog kennels and horse stables. In horse stables, not for application if horses will be used for food.

CONTACT SPRAY - Kills and Reduces Infestation. **FLEAS, COCKROACHES, CRICKETS, SILVERFISH, ANTS, CARPET BEETLES, CENTIPEDES, EARWIGS, FLOUR BEETLES, GRAIN MITES, MILLIPEDES, SOWBUGS, and SPIDERS.** Apply as a contact spray. Fill spray tank with CENOL FLEA SPRAY. Keep spray nozzle about 8 to 12 inches from surface to be treated. Adjust pressure and nozzle to deliver a coarse wet spray. When possible, spray directly on pests to reduce infestations. Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators and other appliances, baseboards, and storage areas. Apply spray until area is moist, but not to the point of run-off. Spray directly on insects where possible. Repeat as necessary. **ANTS:** To kill ants: Spray trails, nests and points of entry within buildings and homes. Spray on ants where possible. Repeat as necessary. **FLEAS:** Aids in the control of fleas on pet bedding and in horse stalls. To reduce reinfestation, thoroughly spray the animals bedding and other resting areas until surface is slightly moist. Treat these areas at a rate of two seconds per linear foot at a distance of 12 to 18 inches. Also spray the entire inside surface of dog houses. Repeat as necessary, thoroughly spraying floors, cracks, crevices and bedding. Hit as many insects directly as possible. To kill **FLEAS and TICKS** on dogs and cats. Apply directly to animals along back, under forelegs and on other areas except scrotum and anus. Part hair to contact skin and insure good coverage. Hold nozzle about one foot away while spraying. Apply until hair is thoroughly moist. Do not spray directly in eyes or mouth.

RESIDUAL SPRAY. Aids in the control of **FLEAS, COCKROACHES, CRICKETS, SILVERFISH, ANTS, CENTIPEDES, EARWIGS, GRAIN MITES, SOWBUGS and SPIDERS.** Kills up to 4 weeks. Spray baseboards, cracks, and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sinks and cupboards in kitchens and bathrooms. In basements, spray hiding places in cracks and crevices, lower walls and dark places. Apply as a coarse, wet spray in a 4 to 6 inch band until area is thoroughly wet but not to point of run-off. Repeat as necessary. Do not use in edible product areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. In the home cover or remove exposed foods. Avoid contamination of cooking utensils and food preparation surfaces.
