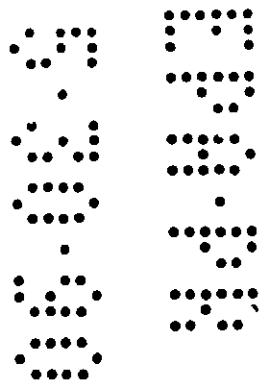

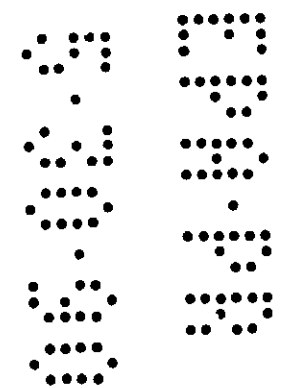

KENNELS AND PET ANIMAL QUARTERS: to control Fleas, Ticks Contact spray treatment. Contact as many insects as possible in addition to thoroughly spraying all parts of the room suspected of harbouring the pests. Special attention should be paid to cracks, behind stoves and refrigerators and wherever the pests are suspected of hiding. Remove and destroy old pet bedding. Spray sleeping quarters of pets. Do not spray animals. Put fresh bedding in pet's quarters after spray has dried. Treat dogs and cats with a registered flea and tick control product before allowing them to enter the treated area. Repeat as needed.

DOMESTIC DWELLINGS, COMMERCIAL, INDUSTRIAL, and INSTITUTIONAL AREAS, (non-food Areas) RAILROAD CARS, TRUCK TRAILERS to control: Bees, Flies, Flying moths, Gnats, House fly, Mosquitoes, Wasps: Space spray treatment. Close room, warehouse, or other area to be treated and shut off all ventilating systems. Dispense product as a fine mist. Do not remain in treated areas. Leave room closed for 0.5 hour. Ventilate the area after treatment is completed. Repeat application as necessary for insect control. Ants, Brown dog tick, Carpet beetles, Cockroaches, Confused flour beetle, Crickets, Firebrats, Fleas, Rice weevil, Sawtoothed grain beetle, Silverfish, Sowbugs, Spiders, Ticks, Waterbugs: Contact spray treatment. Contact as many insects as possible in addition to thoroughly spraying all parts of the room suspected of harbouring the pests. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators and wherever the pests are suspected of hiding. Repeat as necessary. For ant control, treat doors, around window frames, ant trails, and other areas of entry. For carpet beetle control, spray both the interior and exterior of upholstered furniture and also spray the top and bottom of rugs and carpets. Spray shelves, closets, areas under furniture and wherever the insects are seen or suspected. For control of exposed forms of confused flour beetle, rice weevil, and sawtoothed grain beetle, find and destroy infested package foods. Remove all other pantry items. Spray the shelves to kill any insects present. Place clean paper on the shelves and return packages after shelves have dried. For flea and tick control, remove and destroy old pet bedding. Spray sleeping quarters of pets. **DO NOT SPRAY ANIMALS.** Put fresh bedding in pet's quarters after spray has dried. Treat dogs and cats with a registered flea and tick control product before allowing them to enter the treated area.
