SHAKE WELL BEFORE USING

{For trigger spray bottles} Unless otherwise noted, hold container upright and spray from a distance of 12 to 15 inches. {For non-trigger spray containers} Transfer product to compressed air or non-thermal mechanical application equipment. Hold nozzle at a distance of 12 to 15 inches unless otherwise noted in the directions for use.

When treating surfaces and fabrics where water alone could stain, spray in an inconspicuous area to test for possible staining or discoloration.

INDOORS:

Houseflies, Fruit Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees, Black Flies, Skipper Flies, and Small Flying Moths: Close all doors and windows and ventilating systems. Using non-thermal mechanical or compressed air equipment adjusted to deliver a fine mist, direct spray upward into center of room with a slow sweeping motion. Apply 1 oz. per 1000 cubic feet of space. Direct spray to all parts of the room, especially windows and other light sources which attract these insects. Keep nozzle in constant motion. Leave room and keep area closed for 15 minutes after spraying. Sweep up and discard fallen insects.

Cockroaches, Waterbugs, Palmetto Bugs, Silverfish, Firebrats, Crickets, Scorpions, Spiders, Millipedes, Centipedes, Sowbugs and Pillbugs: Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible.

Ants: Spray trails, nests and points of entry. Spray on ants where possible.

Angoumois Grain Moths: Close doors and windows, direct spray into all parts of room especially around stored food product containers, pallets and darkened areas. Apply 1 oz. for each 1000 cubic feet of space, moving toward the door. Leave room and keep area closed for 15 minutes following treatment.

EXPOSED STAGES OF *Confused Flour Beetles, Saw-Toothed Grain Beetles, Red Flour Beetles, Rice Weevils, Granary Weevils, Grain Mites*: Spray into cracks and crevices, processing and handling equipment, around cartons or containers or other areas where these insects tend to congregate. Keep area closed for 45 minutes to 1 hour after treatment.

Carpet Beetles: Apply as a spot treatment to edges of carpeting and under carpeting and rugs. Make localized application to floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Repeat treatment as needed.

TO KILL *Bed Bugs*: Apply as a spot treatment to cracks and crevices, around baseboards, floorboards, bed boards and walls. First, thoroughly clean and air mattresses and springs. Then spot treat only areas that may harbor bed bugs, concentrating on tufts, folds and seams. Allow treated articles to thoroughly dry before use. Repeat after 4 weeks if necessary. **To treat beds:** Disassemble the bed frame and remove bedding. Do not apply to bedding. Wash bedding and dry using medium to high heat to kill bed bugs. Apply this product to the bed frame, mattress and box spring. Application to mattresses and box springs is intended for treatment of seams, edges and tufts only. Do not saturate the mattress or box spring. Do not treat the entire surface of the mattress or box spring. Allow the spray to dry before using the mattress and/or box spring. Also apply the product to cracks and crevices in sleeping area. Make spot treatment to baseboards, behind pictures/wall hangings, along and underneath carpet edges and to other infested articles/furniture in the bedroom or sleeping area. Do not apply to stuffed animals or toys. **To treat luggage**: Remove contents and spot treat areas that may harbor bed bugs, concentrating on corners, pockets and seams.

TO CONTROL *Clothes Moths* and *Carpet Beetles* on wool and other proteinaceous fibers: Remove infested articles from storage, brush thoroughly, and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus and other storages directing the spray into cracks, joints and crevices. After airing, infested articles may be treated by spraying lightly, keeping nozzle at least three feet from fabric to avoid staining. Allow all sprayed articles to dry thoroughly before use.

Fleas & Ticks (Adults and **Larvae)**: Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters and bed then spot treat floor and floor covering, with special attention to cracks and crevices around baseboards, window and door frames. Place fresh bedding in animal quarters following treatment. Allow to dry thoroughly before allowing pets to contact treated areas. Do not retreat in less than 60 days.

TO KILL *Lice* and *Louse Eggs*: Apply as a spot, crack & crevice treatment. Spray from a distance of 8 to 10 inches. Spray only those garments and parts of bedding, including mattresses and furniture that cannot be either laundered or dry cleaned. Spray in an inconspicuous area to test for possible staining or discoloration. Inspect again after drying. Allow all treated articles to dry thoroughly before use.

TO KILL [CONTROL] [House] Dust Mites: This product controls house dust mites that may cause asthma, hay fever, rhinitis, watery eyes and sneezing. On Upholstered Furniture and Drapes – test fabric in an inconspicuous area to insure dyes will not bleed. Apply as a spot, crack & crevice treatment to fabric surfaces paying particular attention to tufts and seams. Spray until damp. Do not use on delicate fabrics. Allow furniture to dry thoroughly before using. On Carpets – DO NOT APPLY AS A BROADCAST SPRAY AT RESIDENTIAL SITES, in these sites apply only as a spot, crack & crevice treatment. In hotels, motels and other non-residential sites, spray over entire carpet surface with a sweeping motion. Use an overlapping pattern to insure total coverage. After application, brush the surface of the carpet with a broom or brush to insure deep penetration. Allow carpet to dry thoroughly before reentering the treated area. Drying time can be accelerated by using a fan. Leave room while fan is in use until carpet is dry. On Mattresses – spray the top, bottom and sides of mattresses until damp, paying particular attention to tufts and seams. Allow to dry thoroughly before using.

IN ANIMAL QUARTERS AND MILK ROOMS: For rapid control of *Houseflies, Mosquitoes, Gnats,* close windows and doors and shut off ventilating equipment. Using non-thermal mechanical or compressed air equipment adjusted to deliver a fine mist, spray at the rate 2.0 oz. per 1000 cubic feet of space. Direct spray at an upward angle distributing it uniformly throughout the entire area until space is filled with mist. For best results, keep area closed during and for 10 minutes after application. Do not remain in treated area. Ventilate thoroughly before re-entering. Repeat treatment after 10 days or at intervals needed to give adequate protection.

TO TREAT LIVESTOCK: To protect beef cattle, dairy cattle, goats, sheep, hogs and horses from attacks of *Stable Flies, Horse Flies, Deer Flies, Face Flies, Houseflies, Horn Flies, Mosquitoes,* and *Gnats:* Spray on each side of animal being careful to spray back, withers and forelegs thoroughly. To protect from *Face Flies*, spray the face and head, but do not spray into eves. Repeat treatment when flies are troublesome.

FOR SWINE: Do not ship animals for slaughter within 5 days of last treatment.

TO CONTROL **Blood-Sucking Lice**: Apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair. Repeat every three weeks if required.

TO CONTROL **Poultry Lice**: Spray roosts, walls and nests or cages thoroughly. Follow by spraying over the birds with a fine mist.

FOR CONTROL OF **Bedbugs** and **Mites** in poultry houses, spray crevices of roost poles, cracks in walls, and cracks in nests where the bedbugs and mites hide.

OUTDOORS:

Point spray nozzle away from face. Hold container on slight downward angle. For best results, spray when air is calm. Allow a few minutes for product to take effect.

Mosquitoes: Apply to shrubbery and vegetation where mosquitoes may rest. Give special attention to breeding areas such as garbage cans and compost piles.

Wasp Nests: Thoroughly spray directly on insects and their nests. Apply in late evening when insects are at rest. Spray into hiding and breeding places, under eaves, in cracks or holes contacting as many insects as possible.
