DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Bayou-Cide 252D is used in cooling water systems and industrial air-washing systems to control microbiological slime. In cooling systems, add 2.3 to 6.8 fl. oz. of Bayou-Cide 252D per 1000 gal. of water to the cooling tower sump. In air-washing systems, add 8.0 to 13.7 fl. oz. of Bayou-Cide 252D per 1000 gal. of water to water-collection trays. Repeat treatments every 1-5 days, or as needed. The required frequency depends on relative amount of bleed and severity of slime problem.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

PESTICIDE DISPOSAL: Pesticide, spray mixture, or rinsate that cannot be used or chemically reprocessed should be disposed of in a landfill approved for pesticides, or buried in a safe place away from water supplies.

CONTAINER DISPOSAL:

METAL: Triple rinse (or equivalent) and offer for recycling, reconditioning, or disposal in an approved landfill or bury in a safe place. Containers over 30 gallons should be resealed before offering for reconditioning.

PLASTIC: Containers under 30 gallons must not be reused but should be triple rinsed and disposed of in an incinerator or landfill approved for pesticide containers or buried in a safe place. Containers over 30 gallons are to be resealed and offered for reconditioning or triple rinsed (or equivalent) and offered for recycling, reconditioning, or disposal in an approved landfill or buried in a safe place.
