C L 3523 is used to control the growth of algae in swimming pools, exterior spas, whirlpools, and hot tubs. For maximum effectiveness pools, spas, whirlpools, and hot tubs containing heavy growth of algae should be cleaned prior to using C L 3523.

For pools having just visible algae growth add an initial dose of 71 to 109 fluid ounces of C L 3523 per 10,000 gallons of water and remove settled algae debris by cleaning. For treatment of a freshly cleaned and filled pool add initially 39 to 71 fluid ounces of C L 3523 per 10,000 gallons of water. Subsequent additions of 13 to 26 fluid ounces of C L 3523 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, or hot tubs having just visible algae growth require an initial dose of 7 to 11 fluid ounces of C L 3523 per 1000 gallons of water. For treatment of a freshly cleaned and filled spa, whirtpool, or hot tub, add initially 4 to 7 fluid ounces of C 1. 3523 per 1,000 gallons of water.
