CLENESCO X-SEPT is a bacteriostatic lubricant for conveyor chains on bottle and can lines in food and beverage plants. CLENESCO X-SEPT is intended for use via continuous application through a lubricant metering system such as a tank with a proportioner pump.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

When used at a dilution of 100 to 1 with water, CLENESCO X-SEPT provides 1941 ppm active ingredients. Continuous application of this concentration to conveyor chains will control the growth of bacteria.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.
