SWIMMING POOL & SPA CONCENTRATED ALGAECIDE

in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs. Heavy growth of algae should be cleaned prior to use.

CONCENTRATED ALGAECIDE

For pools having just visible algae growth add fluid ounces of SW PL & SPA CONC ALGAECIDE per 10,000 gallons of water. For treatment of a hot tub, per 10,000 gallons of water, add initially 41 to 75 fluid ounces per 10,000 gallons of water. Subsequent additions of SW PL & SPA CONC ALGAECIDE per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains require an initial dose of 8 to 12 fluid ounces per 1000 gallons of water. For treatment of a hot tub, or decorative fountain, add initially SW PL & SPA CONC ALGAECIDE per 1,000 gallons of water.

Subsequent additions of SW PL & SPA CONC ALGAECIDE per 1,000 gallons of water should be made every 5 to 7 days after initial treatment.

SW PL & SPA CONC ALGAECIDE is used to treat pools and spas and is effective against algae. SW PL & SPA CONC ALGAECIDE can be used in conjunction with chlorine chemicals and may reduce the amount of chlorine required. However, do not mix SW PL & SPA CONC ALGAECIDE with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty containers.
