in swimming pools, exterior spas, whirlpools, hot tubs, and indoor swimming effectiveness pools, spas, whirlpools, hot tubs. Heavy growth of algae should be cleaned prior to use.

For pools having just visible algae growth add a fluid ounces of SWIMMING POOL CONCENTRATED ALGAECIDE per 10,000 gallons of water. Subsequent additions of SW POOL CONC ALGAECIDE per 10,000 gallons of water should be made every 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, or decorative fountains require an initial dose of 1 to 2 fluid ounces per 1000 gallons of water. For treatment of a freestanding hot tub, or decorative fountain, add initially SW POOL CONC ALGAECIDE per 1,000 gallons of water. Subsequent additions of SW POOL CONC ALGAECIDE should be made every 5 to 7 days after initial treatment. SW POOL CONC ALGAECIDE is compatible with chlorine chemicals and may reduce the amount of chlorine available. However, do not mix SW POOL CONC ALGAECIDE with liquid chlorine products.

STORAGE AND DISPOSAL

STORAGE: Keep container closed when not in use. Containers should be placed in a plastic bag and disposed of with clear water. All pesticides should be kept away from food.

DISPOSAL: Do not reuse empty container.
