

WHERE TO USE IT:

This product is recommended for structural lumber, fences, trellises, millwork and other exterior wood surfaces that are exposed to the natural enemies of wood

TOOLS YOU WILL NEED:

Use brush, roller, pad applicator or spray. Always buy the best quality. You will probably need some drop cloths to protect shrubbery around your home.

SURFACE PREPARATION:

Surface must be clean and dry. This product can be used over previously stained surfaces. Do not apply this product over painted surfaces. Apply liberally by brush, roller, or spray. For extra protection apply a second coat. Do not apply in hot sunlight, if painting is ever desired, surface must be well weathered.

CLEAN OUT TOOLS IN MINERAL SPIRITS.

SPREADING RATE: 200-400 sq. feet (18 5-37 1 sq. meters) depending upon method of application and porosity of the wood

DRYING TIME: To touch 1 hour To recoat, within 1 hour High humidity will cause slower drying
