DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. All loose paint, whitewash, dirt, mildew, oil and other contaminants must be removed to insure a clean surface. This product is supplied ready to use after stirring thoroughly. For interior home use, this product should be applied by brush or rolled on target areas as stated on the front part of this label in the form of a band a few inches in width to obtain an even coat covering approximately 425 s.f. per gallon. For uses other than interior home application, apply with brush, roller or spray. Wash brush, roller or spraying equipment thoroughly with soap and water after use. As contain between the insect and coated surface is necessary, any time that the latter becomes covered with dust or dirt, the coated surface should be washed with clear water in order to re-establish maximum possible contact.

GENERAL

Home Use:

Use to control crawling insects as well as some flying insects in target areas as stated on the front part of this label, of interior or exterior surfaces of homes.

Agricultural, Commercial and Industrial Use:

Use to control crawling insects as well as some flying insects on interior and exterior surfaces of buildings including horse barns, dairy barns, milking parlors, animal hospitals, kennels, manufacturing plants, warehouses, offices, hotels, motels, restaurants, theatres, etc.

Non-Bearing Fruit Trees:

Use to control crawling insects as well as some flying insects by applying Insecta from ground level to a maximum of 3 feet up the trunk of non-bearing fruit trees which include apples, the cherries, citrus fruits, peaches, pears, plums and tree nuts. Non-bearing fruit trees are defined as those which will not bear fruit within twelve months following the application of Insecta.

Kills by contact:

flies, mosquitos, spiders, cockroaches, ants, etc. Dries quickly and rinses easily with water. Covers approximately: 425 sq. ft. per gallon. Allow to dry for several days before washing. Coating must dry for several days before maximum insect control occurs.

STORAGE AND DISPOSAL

Storage:

Store away from freezing temperatures. Disposal: Do not reuse empty container. Wrap container and put in trash collection.
