- 1) Delete the General Precautions and Restrictions heading since "general" may imply that the statements "do not apply" and "do not use" are advisory while they are mandatory statements.
- 2) Add to the Warranty Statements "To the extent allowed by applicable laws" before "Neither this warranty..." and "buyer assumes the risk...."
- 3) Active ingredient-singular since the product contains only one active ingredient.
- 4) We recommend placing the First Aid statements in a box for higher visibility and just below the Signal Word and the "Keep Out Of Reach Of Children. We also recommend having the EPA Reg. No. on the front panel

You must submit one (1) copy of the final printed label before you release the product for shipment. Products shipped after 12 months from the date of this Notice or the next printing of the label whichever occurs first, must bear the new revised label. ## **User Safety Recommendations**

#### **Environmental Hazards**

This product is toxic to fish, aquatic invertebrates, small mammals and birds. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Drift and runoff may be hazardous to aquatic organisms in water adjacent to treated areas. Do not contaminate water when disposing of equipment wash water or rinsate.

This product is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees are visiting the treated areas.

### **DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

#### General Precautions and Restrictions

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. Do not use this product on manhole covers in storm drain systems.

#### **Application Restrictions**

Do not enter or allow others to enter until sprays have dried.

Do not allow spray to drift from the application site and contact people, structures people occupy at any time and the associated property, parks and recreation areas, nontarget crops, aquatic and wetland areas, woodlands, pastures, rangelands, or animals. For ground boom applications, do not apply within 25 feet of rivers, natural ponds, lakes, streams, reservoirs, marches, estuaries and commercial fish ponds. Apply with nozzle height no more than 4 feet above the ground or crop canopy and when wind speed is 10 mph or less at the application site as measured by an anemometer. Use coarse spray according to ASAE 572 definition for standard nozzles or VMD for spinning atomizer nozzles.

The applicator also must use all other measures to control drift.

Insure that all surfaces are clean and dry prior to applying this product. Each gallon covers approximately 500 square feet. This ready-to-use product should be stirred thoroughly prior to application. Apply with brush, roller or handled pad applicator, or by course, low pressure spray. For best results, use without dilution. If necessary, dilute with up to 5% water.

CRACK AND CREVICE TREATMENT: Apply Insecta as a course, low pressure (20 PSI or less) spray with equipment capable of delivering a pinstream of insecticide directly into openings leading to voids and hollow spaces in walls, equipment legs and bases, or at points that occur between different elements of construction or especially where equipment joins floors and walls. Use an applicator fitted with needle injector or equipment capable of delivering a pinstream of insecticide. Use equipment with plastic rather than rubber hoses because the solvents in the insecticide may cause collapse of the rubber. Prior to application, de-energize equipment and allow time for solvent to evaporate before starting motors or placing on "ON" position. Do not apply Insecta on or near flames or heated surfaces.

FOOD MUST BE REMOVED OR COVERED DURING TREATMENT: SPOT TREATMENT controls German and American cockroaches as well as houseflies in and around both food and non-food areas.

Apply Insecta with a 3 in to 4 in brush, roller or handled pad applicator to localized areas where these pests have been seen or are suspected of hiding or entering. Apply only enough to wet the surface. Avoid runoff. Do not allow the insecticide to contact food or food processing surfaces. Areas to be treated include around plumbing and other utility installations, dark corners and closets, along and on baseboards, moldings, around doors, windows, ventilators and other openings. Apply adjacent to tin paneling or other material loosely attached to walls. Floor drains, garbage rooms and locker rooms should be included in treatment. Treated surfaces should not be washed or cleaned for 36 hours after application.

TREATMENT OF SEWER MANHOLES: (For control of roaches). Apply product on manhole walls and covers. Product may be applied via coarse spray using conventional airless spray equipment or by applying with suitable brush or roller. Apply no more than 48 ounces (3 pints) of product to each manhole. Do not discharge spray or unused material directly into sewer system. Do not apply product within 36 hours of predicted heavy rainfall.

ATTENTION: Dries quickly and rinses easily with water. Allow to dry for several days before washing. As contact between the insect and the treated surface is necessary, any time that the latter becomes coated with dust or dirt, the treated surface should be washed with water in order to re-establish maximum possible contact. INSECTA applied on exposed glass, glazed tile, metal or other non-porous surfaces may dry leaving a light film.

KILLS BY CONTACT: American Cockroaches, German Cockroaches and Houseflies.

#### Storage and Disposal

Do not contaminate water, food or feed by storage and disposal.

Pesticide Storage: Store in original containers and do not allow to freeze.

<u>Pesticide Disposal</u>: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
