
TO KILL COCKROACHES, ANTS AND CRICKETS: Spray on floors along baseboards in the kitchen and baths. Special attention should be paid to areas around refrigerators and entry points such as doors, windows, vents, pipes, etc.

TO KILL FLYING INSECTS (mosquitoes, houseflies and gnats): Close space to be treated. Spray above head with a sweeping arm motion 3 feet from surfaces. Spray (10 seconds) per 1000 cubic feet of space. Keep treated areas closed for at least 30 minutes after spraying. Ventilate area before re-entry.

TO KILL SOWBUGS, CENTIPEDES, SILVERFISH, FIREBRATS AND SIPIDERS: Contact as many insects as possible with the spray. Also, thoroughly spray all parts of the room suspected of harboring these insects. Special attention should be paid to cracks, crevices, hidden surfaces under sinks and behind refrigerators.

TO KILL FLEAS AND BROWN DOG TICKS: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, windows and door frames, wall cracks and local areas of floors.
