How To Apply Insecta Spray

Kills cockroaches, ants, spiders, flies, mosquitoes, millipedes, ticks, gnats, palmetto brigs, silverfish, earwigs, crickets, fire ants, gypsy moths, scorpions and black widow spiders by contact with residual action.

Apply a barrier of Insecta Spray as a crack and crevice and spot treatment.

Directions For Use
