STATEMENT OF PRACTICAL TREATMENT

Swallowed — Induce vomiting by giving one (1) tablespoonful (½ oz.) of Syrup of Ipecac (for patients one year or older) followed by one 8-ounce glass of water. If vomiting does not occur in 15 minutes, the dose may be repeated only once. If Syrup of Ipecac is not available, vomiting should be induced by sticking a finger down the patient's throat.
CALL A PHYSICIAN

If in eyes — Immediately flush eyes with plenty of water for at least 15 minutes holding the eyelids open. Get medical attention if irritation persists.

If on skin — Wash skin immediately with soap and plenty of water.

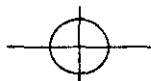
