STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area inaccessible to children and pets and away from heat or open flame.

DISPOSAL: Replace cap, wrap container in several layers of newspaper and discard in trash. Do not incinerate or puncture.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. To operate, hold can upright, direct orifice toward the surface to be treated and press the actuator button. Do not use as a space spray. Do not spray near heat or open flame.

To kill crawling insects: **Ants, Carpet Beetles, Centipedes, Cockroaches, Crickets, Earwigs, Fire Brats, Pillbugs, Silverfish, and Spiders**, thoroughly apply as a spot treatment to areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices, under carpets, along baseboards and door sills, and frames; behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly. Spray ant trails, nests, and points of entry.

To kill **Brown Dog Ticks and Fleas**, apply thoroughly as a spot treatment to infested areas such as pet beds and resting quarters and nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Fresh bedding should be placed in animal quarters following treatment. Do not spray pets with this product. Treat pets with a product registered for application to pets to control the source of flea infestation.

To control flying insects: **Flies, Gnats, Hornets, Mosquitoes, Small Flying Moths, Wasps, and Yellow Jackets**, use only on outdoor surfaces. Spray surfaces of window and door frames, and other areas where these pests may enter the home. Also spray dark corners and localized resting areas, such as under eaves, porches, partitions, and in garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surfaces will be killed. Repeat treatment when effectiveness diminishes.

Food Handling Establishments

Places other than private residences in which food is held, processed, prepared or served such as restaurants, institutions, and hotels.

Food Areas

Application limited spot or crack and crevice treatment only. For spot treatments, no individual spot will exceed two (2) square feet.

Includes areas for receiving, storage packing, (canning, bottling, wrapping, boxing), preparing, edible waste storage, and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas when food is exposed and facility is in operation are also considered a food area.

Remove or cover food prior to treatment.

Use as directed above and apply in small amounts directly into cracks and crevices using the crack and crevice tip delivering a pinstream of insecticide in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where cockroaches, ants, silverfish, firebrats, spiders, and crickets hide. Spot treatment using coarse spray may also be made to areas where any of the above pests hide or inhabit such as baseboards, storage areas, closets, around water pipes, doors, and windows, behind and under refrigerators, cabinets, sinks, stoves, and other equipment, the underside of shelves, drawers, and similar areas.

Make applications so as to avoid possible splashing of the spray. Avoid contamination of food or food processing surfaces.

Non-Food Areas

FICAM® PLUS® R/S may be used as a crack and crevice treatment or as a spot application in non-food areas. All areas where insects hide or through which insects may enter should be treated.
