Amend Registration To Comply with PR Notices
94-1 and 95-1 and To Correct Chemical Expression
of Glufosinate-Ammonium

The proposed amendments described in the subject application and letter have been reviewed. The proposed label as submitted is acceptable under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as amended, provided that you:

1. Revise the use sites for which this product may be used for formulation into other pesticide products by deleting the reference to "nonselective and selective" weed control; and by adding the words "glufosinate-ammonium tolerant" to qualify the use sites corn and soybeans. The nature of the herbicidal activity is not considered part of the use site. Although labeling bearing the claims "nonselective and selective" have been accepted for your end-use products derived from this product, the use of these qualifying words is confusing and they need explanation when used alone, such as used in this label.
2. Submit one (1) copy of your final printed label prior to releasing this pesticide product for shipment under the subject label, after revision as directed in comment 1 above.

If these conditions are not complied with, the registration
