 - The label must include restricted use labeling according to PR Notice 93-1. In the Restricted Use Pesticide Information Box, add the phrase "Toxic to Aquatic Organisms".

GENERAL INFORMATION

MONCUT® 50WP is a systemic funcicide for control of sheath blight, R. solani, in rice.

APPLICATION AND DOSAGE

RICE

Apply MONCUT 50WP aerially in 5-10 gpa water, using one of the following schedules:

- Apply MONCUT 50WP at 0.7 to 1.0 pound per acre to rice at first internode
 elongation, and follow with a second application at the same rate 10 to 14 days
 later. Use the higher rate where disease pressure is expected to be heavy.
- MONCUT 50WP when 5-10% of the tillers of a susceptible variety or 10-15% of a moderately susceptible variety have sheath blight lesions. Apply MONCUT 50WP at 0.7 to 1.4 pounds per acre. Continue scouting and reapply if disease begins to move up the rice stem again.

USE PRECAUTIONS

Apply no more than a combined total of 2.0 lbs. MONCUT 50WP per acre to rice as a broadcast application during a single growing season.

Do not apply later than 30 days prior to rice harvest, or beyond 75% heading development stage, whichever occurs first.

Do not use oil as a carrier or add other additives to the finished spray.

This pesticide is toxic to shrimp.

Flooded fields may be used for aquaculture of crayfish only following rice harvest.

Do not plant rotational crops other than rice or peanuts for 12 months following the last application of MONCUT, with the following exceptions:

 Soybeans or grain sorghum may be planted 240 days or more following the last application of MONCUT to rice.

ENDANGERED SPECIES

Restrictions in the State of Arkansas

The use of MONCUT (flutolanil) on rice is restricted to protect the endangered fat pocketbook pearly mussel (*Potamilus capax*) and its habitat. Use is prohibited in the following areas of Arkansas:

Mississippi County: Within the basin that drains directly into the Right Hand Chule of Little River, south of Big Lake National Refuge.

Poinsett County: Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River and the St. Francis Floodway. Use is also prohibited west of Rt. 140 and north of Rt. 63 at the SIPHON near Marked Tree. Except that the prohibited area does not include the area bounded by Arkansas Highway 373 on the west, Highway 63 on the east and Highway 14 on the south.

Cross, St. Francis, and Lee Counties: Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River and the St. Francis Floodway as far south as the confluence of L'Anguille River (Lee County).
