Subject: NOTIFICATION of Change in Warranty Disclaimer Statement

AgrEvo USA Company is herein notifying the Agency of a change to all our product labels. Specifically, we are changing the warranty disclaimer statement.

The warranty statement currently used on labels has been in effect since 1993 after the Agency was notified of the statement in a letter dated November 19, 1993 (the statement was subsequently altered slightly as a result of the company name change from NOR-AM Chemical Company to AgrEvo USA Company in 1994). A copy of the current statement is included here as Attachment A. The new statement, which will be used on newly produced product labeling, is presented herewith as Attachment B.

This notification is consistent with the provisions of PR Notice 95-2 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 95-2 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.
