

Liberty ATZ Herbicide is a suspension concentrate herbicide intended for application as a foliar spray for the control of a broad spectrum of emerged annual and perennial grass and broadleaf weeds in corn. This product is for use only on corn tolerant to the active ingredient in this product. AgrEvo USA Company recommends use only on seed designated as LibertyLink or warranted by AgrEvo USA Company as being tolerant to Liberty ATZ Herbicide. The basis of selectivity of Liberty ATZ Herbicide in corn is the presence of a gene in LibertyLink or other AgrEvo warranted corn hybrids which results in a plant that is tolerant to the active ingredient of Liberty ATZ Herbicide.

#### IMPORTANT CROP SAFETY INFORMATION READ BEFORE USING THIS PRODUCT

Liberty ATZ Herbicide is for use only on corn tolerant to glufosinate-ammonium, one of the active ingredients in this product. AgrEvo USA Company recommends use only on seed designated as LibertyLink or warranted by AgrEvo USA Company as being tolerant to Liberty ATZ Herbicide.

The basis of selectivity of Liberty ATZ Herbicide in corn is the presence of a gene in LibertyLink or other AgrEvo warranted corn hybrids which results in a plant that is tolerant to the active ingredient of Liberty ATZ Herbicide. Corn not containing this gene will not be tolerant to Liberty ATZ Herbicide and severe crop injury may result.

Use of Liberty ATZ Herbicide on corn not designated as LibertyLink or not warranted by AgrEvo may result in severe crop injury and/or yield loss.

Do not allow spray to contact foliage or green tissue of desirable vegetation other than corn tolerant to glufosinate-ammonium. This product may injure or kill all green vegetation contacted by the spray other than LibertyLink corn or other corn hybrids warranted by AgrEvo.

AgrEvo does not warrant the crop safety or weed control of this product if used on corn other than that designated as LibertyLink or warranted by AgrEvo to safely withstand the application of Liberty ATZ Herbicide.

THOROUGH SPRAY COVERAGE IS VERY IMPORTANT. Visual effects and control from Liberty ATZ Herbicide applications occur within 3 to 6 days after application under good growing conditions. Liberty ATZ Herbicide works best when weeds are actively growing. A cultivation may be made at least 5 days before a Liberty ATZ Herbicide application or 5 days after a Liberty ATZ Herbicide application.

#### **APPLICATION TIMING**

Liberty ATZ Herbicide is a foliar-active material with soil-residual activity. Liberty ATZ Herbicide (alone and in tank mixes) may be applied following any corn preplant incorporated or preemergence herbicide applications. Best results are obtained when applications are made to actively growing weeds. Liberty ATZ Herbicide will have an effect on weeds that are larger than the recommended leaf stage, however speed of activity and control may be reduced. Applications of Liberty ATZ Herbicide following the use of soil-applied insecticides will not injure corn.

Applications of Liberty ATZ Herbicide on corn may be made from emergence until corn is 12" tall.

Liberty ATZ Herbicide is rainfast four (4) hours after application to most weed species, and rainfall within four (4) hours may necessitate retreatment or may result in reduced weed control. Applications should be made between dawn and one hour before: sunset to avoid the possibility of reduced control of lambsquarters and velvetleaf. Do not apply when wind causes drift to off-site vegetation as injury may occur. Weed control may be reduced if application is made when heavy dew, fog and mist/rain are present or when weeds are under stress due to drought, cool temperatures or extended periods of cloudiness.

Apply Liberty ATZ Herbicide at rates of 32 fluid ounces/acre (2 pints/acre) to 48 fluid ounces/acre (3 pints/acre).   - Do not rotate to any crop except corn until the following year, or injury may occur.
  - If applied after June 10, do not rotate with crops other than corn or sorghum the next year, or crop injury may occur.
  - In the high plains and intermountain areas of the west where rainfall is sparse and erratic or where irrigation is required, use only when corn or sorghum is to follow corn or sorghum or when a crop of untreated corn or sorghum is to precede other rotational crops.

#### SPRAY ADDITIVES

Liberty ATZ Herbicide must be applied with ammonium sulfate (AMS). Use only fine-feed-grade or spray-grade AMS at 3 pounds per acre or 17 pounds per 100 gallons of water. Do not add any surfactants or crop oils. Antifoams may be added if needed.

#### MIXING INSTRUCTIONS

**Shake well before use.** Liberty ATZ Herbicide must be applied with properly calibrated and clean equipment. Prior to adding Liberty ATZ Herbicide to the spray tank, ensure that the spray tank is thoroughly clean, particularly if a herbicide with the potential to injure crops was previously used (see *Cleaning Instructions*).

Liberty ATZ Herbicide must be mixed with water to make a finished spray solution as follows:

- 1. Shake product container well before opening and using.
- 2. Fill the spray tank half full with water.
- 3. Start agitation.
- 4. Prepare a slurry of the proper amount of dry flowable/wettable powder tank mix partners in a small amount of water.
- 5. Add the slurry of dry materials to the spray tank.
- 6. Add the appropriate amount of AMS to the spray tank.
- 7. Add the proper amount of liquid tank mix partners.
- 8. Complete filling the spray tank with water.
- 9. Add the proper amount of Liberty ATZ Herbicide and continue agitation.
- 10. If foaming occurs, use an antifoam agent.

Ensure that all spray system lines including pipes, booms, etc. have the correct concentration of Liberty ATZ Herbicide/water mixture before the application is started. Flush out any remaining air or water from the spray system lines before starting the crop application. Keep bypass line on or near bottom of tank to minimize foaming.

If tank mix partners are added, maintain good agitation at all times until contents of the tank are sprayed. If the spray mixture is allowed to settle, thorough agitation is required to resuspend the mixture before spraying is resumed. Keep bypass line on or near bottom of tank to minimize foaming. Screen size in nozzles or line strainers should be no finer than 50 mesh.

#### CLEANING INSTRUCTIONS

Before mixing Liberty ATZ Herbicide, thoroughly clean nurse tanks, spray tank, lines and filter, particularly if a herbicide with the potential to injure crops was previously used. Spray equipment should be thoroughly rinsed using a strong detergent solution.

After using Liberty ATZ Herbicide, triple rinse sprayer and use a commercial tank cleaner before using in crops not labeled LibertyLink or warranted by AgrEvo. Make sure any rinsate or foam is thoroughly removed from spray tank and boom. Rinsete may be disposed of according to the requirements contained in the *Environmental Hazards* section of this label.

#### **APPLICATION METHODS**

)

Uniform, thorough spray coverage is important to achieve consistent weed control. For best results, use flat-fan nozzles with medium size droplets at or about 300 microns. Do not use flood-jet nozzles, controlled droplet application equipment or air-assisted spray equipment.

**Ground Application:** Refer to the *Rate Recommendation Tables for Weed Control* in the following section for the proper application rates. DO NOT apply when winds are gusty, or when conditions will favor movement of spray particles off the desired spray target. To avoid drift and ensure consistent weed control, apply Liberty ATZ Herbicide with the spray boom as low as possible while maintaining a uniform spray pattern. DO NOT apply at ground speeds exceeding 12 mph. Liberty ATZ Herbicide should be applied broadcast in a minimum of 15 gallons of water per acre. Under dense weed/crop canopies 20 to 40 gallons of water per acre should be used so that thorough spray coverage will be obtained.

The use of 80-degree or 110-degree flat-fan nozzles is highly recommended for optimum spray coverage and canopy penetration. Use a spray pressure of 30 to 60 pounds per square inch (measured at the nozzle). If using Turbo TeeJet<sup>®</sup> spray tips, use a pressure of 60 pounds per square inch so that thorough spray coverage will be obtained.

**Aerial Application:** Use only the 48 fluid ounces per acre rate of Liberty ATZ Herbicide for aerial application. Poor coverage will result in reduced weed control. Liberty ATZ Herbicide should be applied in a minimum of 5 gallons per acre of total spray solution using spray nozzle tips and sufficient pressure to provide a uniform pattern and median droplet size of 300 to 350 microns. DO NOT use raindrop nozzles. Aerial applications with this product should be made at a maximum height of 10 feet above the crop with low drift nozzles at a maximum pressure of 40 psi.

Avoid application under conditions where uniform coverage cannot be obtained or where excessive spray drift may occur. Do not apply when wind causes drift to off-site vegetation.

#### RATE RECOMMENDATION TABLES FOR WEED CONTROL

Apply Liberty ATZ Herbicide at rates of 32 fluid ounces/acre (2 pints/acre) to 48 fluid ounces/acre (3 pints/acre). Rates in ounces of formulated product per acre for the control of weeds at selected heights are shown in the following tables. In weed populations with mixed species, apply the rates needed for all species-present.
