DIRECTIONS FOR USE GENERAL CLASSIFICATION

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Esco-Cide 15 is used in cooling water systems and industrial air-washing systems to controt microbiological slime. In cooling systems, add 3.4 to 10.3 fl. oz. of Esco-Cide 15 per 1000 gal. of water to the cooling tower sump. In air washing systems, add 12 to 20.5 fl. oz. of Esco-Cide 15 per 1000 gal. of water to water collection trays. Repeat treatments every 1.5 days, or as needed. The required frequency depends on relative amount of bleed and severity of slime problem.

Esco-Cide 15 is used to control sulfate-reducing bacteria in petroleum secondary recovery waterflooding operations at dosages of 2.8 to 5.7 fl. oz. of Esco-Cide 15 per 1000 gal. of water treated. Technical assistance in applying Esco-Cide 15 to a particular secondary recovery system is available upon request when a description of the problem is provided.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.
