HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER: Corrosive, may cause severe skin irritation or chemical burns to broken skin. Causes eye damage. May be fatal if swallowed. Avoid breathing vapors. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling this product. Wash hands after handling. Vacate poorly ventilated areas as soon as possible. Do not return until odors have dissipated.

GENERAL CLASSIFICATION

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

DIRECTIONS FOR SWIMMING POOL CHLORINATION

For a new pool or for spring start-up, superchlorinate with one (1) pint (16 fl. oz.) of sodium hypochlorite solution for each 2500 gallons of water. This dosage is equivalent to 5 ppm available chlorine by weight.

FOR POOL MAINTENANCE

- A) Adjust pool water pH to 7.6 - 7.8 range and maintain.
B) Add manually or by a feeder device sodium hypochlorite solution at a rate to maintain an available chlorine residual of 0.6 to 1.0 ppm. One half pint (8 fl. oz.) of sodium hypochlorite solution for each 6000 gallons of water will provide 1.0 ppm available chlorine by weight. Frequency of additions to maintain 0.6 to 1.0 ppm available chlorine will depend on temperature and number of swimmers. Use test kit to make certain the pH and chlorine residual are in the proper range.

NOTE: This product degrades with age. Use a chlorine test kit and increase dosage, as necessary, to obtain the required level of available chlorine.

STORAGE AND DISPOSAL: Store in a cool, dry area away from direct sunlight. In case of spill, flood area with large quantities of water. Rinse empty container thoroughly with water and either return to manufacturer or discard by placing in trash collection or by recycling in an approved land fill. Product or rinsate that cannot be used, should be diluted with water and disposed of in a sanitary sewer. Do not contaminate food or feed by storage, disposal or cleaning of equipment.
