<u>Mold inhibitor for Latex Paint</u> - Exterior exposure testing suggests certain loadings as starting points for the evaluation of THIONIC. For exterior latex paints, use 1 to 3% of THIONIC based on total weight (equal to about 10 to 30 lbs. per 100 gallons), added during the pigment dispersion stage of manufacture.

Do not use in formulation containing metallic drier.

<u>Mold Resistant Paper and Paperboard</u> - To impart mold resistant properties to paper or paperboard, apply as a surface treatment on size press or calendar stack.
