The directions for use on surfaces and fabrics as a spray must be revised to make clear the product may only be used to spray dog and cat bedding.

#### DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

#### READ ENTIRE LABEL BEFORE EACH USE. USE ONLY ON DOGS AND CATS.

#### For Use on Dogs and Cats:

- 1. Apply *DeFlea P et Shampoo* onto coat of pet. Work shampoo into pet's coat until a lather is formed. Be sure that entire pet is treated, including hard to reach areas such as between paws.
- 2. Rinse animal thoroughly, then dry.
- 3. Repeat as necessary, but not more often than at 3-day intervals.

**NOTE**: It is vital for young puppies and kittens to maintain a normal body temperature. Take precautions to provide a warm environment during and after bathing.

#### For Use as a Spray:

- 1. Spray entire animal, including legs and paws. Stroke the animal's coat against the lay while spraying to make sure the solution reaches the skin. Spray until entire coat is damp.
- 2. To help solution penetrate to the skin, spray and work into the coat.
- 3. Dry with towel if desired. (no rinsing is required).
- 4. In addition to pet, spray on surfaces and fabrics that may be infested, making sure adequate product is used to saturate areas where fleas may be hiding. Contacting fleas with product is required to achieve results.
- 5. Repeat as necessary, but not more often than at 3-day intervals.

#### For Use on Reptiles:

[Brand name] kills mites and other reptile parasites using a different mode of action than pyrethrin base pesticides.

- 1. Spray directly on reptile, but not to excess (runoff) and all areas where mites may hide. Avoid spraying eyes and facial areas. Alternatively, spray [brand name] onto a cloth and wipe onto rep-tile.
- 2. Reapply as often as necessary, but not more often than at 3-day intervals.
- 3. Do not treat snakes for at least 6 hours after shedding their skin.
