The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

1. Since the product is limited to use by veterinarians, you do not have to add the paragraph on "Diagnosis" in paragraph 1 of our May 22, 1991 letter.

Submit five copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records.

The Confidential Statement of Formula (CSF) dated August 10, 1993 will not meet the label claim for the nominal concentration for the active ingredients. The upper and lower certified limits are based on the pure active ingredient rather than the technical or concentrate. Refer the PR Notice 91-2 and 40 CFR 158.175 for guidance and revised the CSF and the labeling ingredient statement to reflect the nominal concentration of the pure active ingredient.
