



[Two-Way Sprayer: Turn nozzle to stream for crack and crevice applications. Turn nozzle to spray for surface applications or to kill flying insects.]



Indoors

Ants, Roaches & Flies: In a well-ventilated room, spray away from your face sufficiently to wet, kill and then repel crawling ants, roaches and other listed insect pests (and odor-causing microorganisms they might carry) in homes, restaurants, hospitals, schools, food processing establishments and elsewhere. Spray kitchen cabinets, drawers, and closets, under sinks and into wall and floor cracks and crevices in both edible and non-edible product areas of Federally-approved meat, poultry and egg producing establishments. Kill flies and mosquitoes in air and on all surfaces attracting them using the wide spray nozzle setting. Reapply as needed.

Fleas: Hold container tilted down away from your face and with a sweeping side-to-side motion and the wide spray nozzle position kill adult fleas hidden in carpets, rugs and dog and cat bedding and under furniture. 16 oz. will kill fleas on contact over a 200 sq. ft. area. Reapply as needed. Before spraying, test a corner of fabric for compatibility.

Outdoors

Crawling & Flying Pests: Hold container upright and spray away from your face sufficiently to wet, kill and then repel crawling ants, including fire ants, roaches, spiders and flies, "no-seeums," and mosquitoes in air and on surfaces. Thoroughly spray and wet ant trails on sidewalks, paths and buildings and one foot on either side. Spray ground holes where ants live. Spray garbage cans, dumpsters and manure piles to kill flies, roaches and ants and their eggs, larvae and pupae on contact. Using the narrow spray position standing as far away as possible, squirt liquid into hornet, wasp and yellow jacket nests. Do not spray plants.

Barbeques & Picnics: Control Pesky Insects Outdoors: Lightly spray tables, BBQs and grills, paths and grass a few minutes or so before your party starts and food is served. Spray all surfaces you wish to keep free of flying and crawling insects. Reapply as needed.

Storage and Disposal

Storage: Store container in a cool, dry place. **Disposal: if empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
