On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.

2. Make the following label changes before you release the product for shipment:

- a. Add the phrase, " EPA Registration No. 45987-3 ".
- b. Delete all reference to the use of "premoistened puffs" If you desire to pursue registration of the use, you must apply for a new registration.
- c. Delete the label claim for "flies" and replace it with "biting flies".

The copy of the reprint from the Journal of Medical Entomology, Hink, W.F. and Fee, B.J., was found not to be sufficient to support the additional insect claims listed in your letter of June 20, 1994 for the subject product. Supporting efficacy data must be conducted on the product as formulated and as used in accordance with label directions and must show that the product produces the desired repellency effect.

d. Delete the label claim "Resists perspiration". Additional efficacy data showing that effectiveness of the product is not affected by perspiration is needed to support this claim.

e. Add the following statement: "Discontinue use if skin irritation occurs."

f. Relocate the statement, "In case of unwanted contact, flush with plenty of water." from its present location to the paragraph headed "To apply to the face." as it appeared on your previously submitted label for the product.

g. Reinstate the statement "Hold this package 6 inches away." as it appeared on your previously submitted label under the heading, "To apply to the body."

h. Revise the container disposal instructions to read as follows: "Wrap empty container and put in trash."

i. Delete the heading, "Precautionary statements" appearing on your label as a heading for the storage and disposal statements. This heading should be replaced with the heading, "Storage and Disposal Statements."

3. You will submit the data listed below conducted in accordance with the Pesticide Assessment Guidelines for the study, no later than July 31, 1995.

Guideline No. 82-3: 90 day dermal study

This study, which is to be conducted on the subject product will also satisfy the 90 day dermal study requirement for your pending "Bugchaser Insect Repellent Strip" (EPA File Symbol 45987-U). The submittal due date established in this Notice of Registration shall be the same date specified in any subsequent Registration Notice which may be issued for your pending product. We cannot grant your request that you be permitted to submit this study within one year following registration of your pending "Bugchaser Insect Repellent Strip" product.

4. Submit two copies of the revised final printed label before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 5(e). Your release for shipment of the product constitutes acceptance of these conditions.
