The amendment referred to above, submitted in connection with registration of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is conditionally acceptable provided the following changes are made:

Place the First Aid treatment regimen in the following descending order: Eyes, Skin, Swallowed, Inhaled.

In summary, your request to change the weekly maintenance dosage from 3 ounces to 4 ounces is acceptable. A copy of your conditionally accepted stamped label is enclosed. 

This product kills algae and clears the water in your swimming pool without requiring pool closing and without foaming.

THEO DEPOSITED AS

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

APPEARING AND HOST LEAD.

VISIBLE ALGAE GROWTH: 16 oz of this product per 10,000 gallons of pool water. INITIAL CLEAN WATER TREATMENT: 9 oz. of this product per 10,000 gallons of pool water.

MAINTENANCE: 4 oz. of this product per 10,000 gallons of pool water weekly.

Pools containing heavy algae growth should be cleaned prior to using this product. 24 hours after treating visible algae growth, algae debris should be removed by standard cleaning procedures. Dilute this product with at least nine parts water before applying. Pour required amount of this product into plastic watering can and fill with water. Maintaining constant pool circulation, sprinkle solution around the edge of the pool.

IMPORTANT NOTE: Always apply chemicals separately. Never combine them.
