

Hand Sanitizing — In food handling and meat cutting operations: Rinse hands and immerse in a 1 oz. **SANI-WAY 175** per 5 gals. of water solution (25 ppm titratable iodine).

Retort Cooling Water — For canning operations — add 1 oz. **SANI-WAY 175** per 5-10 gallons of retort water prior to starting up operation to control slime and odor causing bacteria.

Poultry Drinking Water Sanitization — 1 oz. **SANI-WAY 175** per 10 gallons of drinking water.

Shoe Bath Sanitizer — To prevent tracking harmful organisms into animal area, scrape shoes and place in a 3 oz. per gallon solution of **SANI-WAY 175** for 30 seconds prior to entering area.

Metal Container: Triple rinse (or equivalent), then offer for recycling or reconditioning, or dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. (If container is 1 gallon or less, use this container disposal statement.)

STATEMENT OF PRACTICAL TREATMENT

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse.
