Your Submissions Dated August 19 and October 4, 1996

The Agency has reviewed your submissions for the revised Confidential Statements of Formula, and the following comments apply:

- 1) The Confidential Statement of Formula dated September 20, 1996 for the basic formulation agrees with the label claim in compliance with PR Notice 91-2 and is acceptable.
- 2) The Confidential Statement of Formula dated September 20, 1996 for the alternate formulation agrees with the label claim in compliance with PR Notice 91-2 and is acceptable.

The Confidential Statements of Formula have been added to your file as part of the record.

The Agency has reviewed the proposed ingredient statement submitted in connection with the revised formulations and has determined it to be acceptable with the following provisions:

- a) We note that only the front panel (first page) of the labeling was submitted to demonstrate the revised ingredient statement. Therefore, the proposed labeling is accepted on the condition that the rest of the labeling remains exactly as previously accepted by the Agency on March 13, 1995, including the comments on the Agency correspondence regarding the subject product of the same date.
- b) The heading "Active Ingredients" should be made singular.

- c) Revise the percentage for the inert ingredients in the Ingredients statement to read "54.37%".
- d) Add a substatement to the Ingredients statement to read "Contains Petroleum Distillates".
- e) Revise the Statement of Practical Treatment to read as follows:

"IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention."

"IF SWALLOWED: Call a doctor or get medical attention. Do not induce vomiting. Drink promptly a large quantity of milk, egg whites, gelatin solution, or if these are not available, drink large quantities of water. Avoid alcohol."

"IF ON SKIN: Wash with plenty of soap and water. Get medical attention."

"IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention."

"NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. May pose an aspiration pneumonia hazard."

A stamped copy of the front panel of the labeling is enclosed for your records. Please submit one (1) final printed copy for the entire referenced label, complying with the above provisions, before releasing the product for shipment.
