

### Directions For Use

IT IS A VIOLATION OF A FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

**FOR USE IN COMMERCIAL ESTABLISHMENTS:** Use plastic or rubber squeeze bottle or commercial powder sprayer to blow powder into hidden dry void areas in your structure. This includes wall voids, soffits, electrical conduits, outlets under cabinetry, crawl spaces, sub-floor voids and attic voids. Also apply powder under and behind stoves, refrigerators, dishwashers and in hollow voids of equipment legs. Where pipes come out of the walls, remove decorative ring and blow powder in all directions into these voids. Also treat intersections and corners of shelves in cabinets, cupboards, pantries and closets. **ANY POWDER VISIBLE AFTER APPLICATION SHOULD BE CAREFULLY BRUSHED INTO CRACKS AND CREVICES OR REMOVED. APPLY ONLY IN AREAS INACCESSIBLE TO CHILDREN AND PETS.**

**FOOD HANDLING ESTABLISHMENTS:** Places other than private residences in which exposed food is held, processed, prepared or served. **FOOD AREAS—APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY.** Includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing) preparing edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation also would be considered a food area). Apply in small amounts directly into cracks and crevices using a plastic squeeze bottle or commercial powder sprayer. Apply in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases to control cockroach infestations. **CARE SHOULD BE TAKEN TO AVOID DEPOSITING THE PRODUCT ONTO EXPOSED SURFACES OR INTRODUCING THE MATERIAL INTO THE AIR. AVOID CONTAMINATION OF FOOD OR FOOD PROCESSING SURFACES.**
