

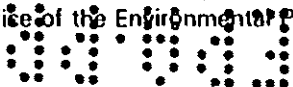

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Sam The Pool Man Concentrated Algaecide is used to control algae in swimming pools, exterior spas, whirlpools, hot tubs, and minimum effectiveness pools, spas, whirlpools, hot tubs, and decorative pools. Heavy growth of algae should be cleaned prior to using Sam The Pool Man Concentrated Algaecide.

For pools having just visible algae growth add an initial dose of 1 to 2 fluid ounces of Sam The Pool Man Concentrated Algaecide per 10,000 gallons of water. Remove algae debris by cleaning. For treatment of a freshly cleaned pool, add 1 to 11 fluid ounces of Sam The Pool Man Concentrated Algaecide per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of Sam The Pool Man Concentrated Algaecide per 10,000 gallons of water should be made every 2 to 4 weeks for maintenance.

Spas, whirlpools, hot tubs, and decorative fountains having algae should require an initial dose of 1 to 2 fluid ounces of Sam The Pool Man Concentrated Algaecide per 1000 gallons of water. For treatment of a freshly cleaned hot tub, or decorative fountain, add initially 0.6 to 1.1 fluid ounces of Sam The Pool Man Concentrated Algaecide per 1000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of Sam The Pool Man Concentrated Algaecide should be made every 2 to 4 weeks after initial treatment for maintenance.

Sam The Pool Man Concentrated Algaecide is compatible with chlorine. It may be used to treat pools, spas, and decorative fountains and hot tubs with an alkaline pH. Sam The Pool Man Concentrated Algaecide can be used on decorative fountains treated with chlorine chemicals and may be used with chemicals normally required. However, do not mix Sam The Pool Man Concentrated Algaecide with concentrated dry or liquid chlorine products.

**STORAGE AND DISPOSAL**

**STORAGE:** Keep container closed when not in use. Empty containers should be placed in a plastic bag and discarded. Rinse with clear water. All pesticides should be kept out of reach of children and away from food.

**DISPOSAL:** Do not reuse empty container. Wrap or burn.
