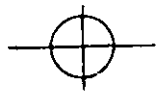

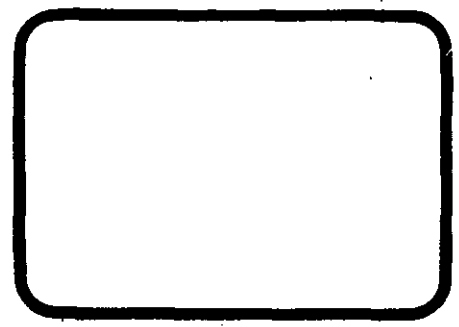

SUPER K-GRO Liquid Fence & Grass Edger is a ready to use, non-selective herbicide that top kills weeds and grasses on contact. Its phytotoxic properties are quickly inactivated on contact with soil. It will not stain paved or graveled areas. Apply as directed to control unwanted vegetation around shrubs, trees, buildings, patios, in brick and gravel walks, and along side fences, driveways, sidewalks, curbs and gutters.

HOW TO APPLY: Remove cap from applicator head and be certain that applicator head is firmly on jug. Invert jug and adjust stream of product by adjusting the angle and height at which you hold the bottle. Thoroughly cover unwanted vegetation with the herbicide. For edging around fences, lawns and sidewalks and top killing vegetation around shrubs, trees and buildings, hold the container 2 to 6 inches from the area to be treated depending upon the desired width of the spray pattern. For controlling weeds in unconfined areas such as gravel walks and driveways or patios, apply 1 gallon to 200 square feet. Holding the jug about waist high and away from the body to avoid contact with skin or clothing, walk slowly making sure that all undesirable vegetation is thoroughly covered with the spray. For spot treating, handle the jug so that the spray hits only the area to be treated.

APPLY ONLY WHEN AIR IS CALM TO AVOID SPRAY HITTING ANY DESIRABLE FOLIAGE. Be careful that spray does not hit green bark, broken bark, buds or leaves of desirable plants. Do not track from treated areas to untreated areas.

For best results, apply during warm, sunny weather. Sunlight and temperatures above 80°F accelerate the destruction of treated vegetation. However **SUPER K-GRO** Liquid Fence & Grass Edger can be applied anytime during the growing season. Under warm, sunny conditions wilting will occur in 1 to 3 days and complete browning in 5 to 7 days. Hard to control perennial weeds such as Bermudagrass and Dallisgrass will require more than one application to give control of top growth.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS CAUTION

Keep children and domestic animals off treated areas until this herbicide has been absorbed into soil. Avoid contact with skin and eyes. Do not breathe spray mist. Wash hands well after using. **May be harmful if swallowed.**
